## Local and regional authorities responsible for practical implementaion


- 21 health care regions
- 21 county administrative boards
- 290 municipalities
- Our county administrative boards cover 52 % of the area in Sweden.
- Jämtland is slightly bigger than Denmark. Västernorrland, approx the size of Slovenia, Andorra and Malta combined. Västerbotten slightly smaller than Croatia. And Norrbotten county – bigger than Portugal and Luxemburg together.



## The mission for crime prevention at the county administrative boards since 2018


- Support the development of knowledge- and problem-based local and regional crime prevention work
- Contribute to the development of cooperation and exchange of experience between relevant actors at local and regional level to prevent crime
- Support skills development and joint cross-sectoral training initiatives in the field of crime prevention
- Support and initiate cross-municipal crime prevention measures.

Internet accsess is mostly excellent and the population is very used to online shopping due to rural living






Mail and parcels can be picked up at Coop and similar grocery stores, if too big to fit in the mail box

## Goal **project**: security for employees + complicate accessability of drugs

2013 Survey among employess (risksituations, working lonely, no routines, feeling of dealing drugs involentary e t c)

2014 Project starts (fundamental components of the method: education, dialogue and cooperation, visability)

2015 After interpreting the postal law by help of lawyers, we come to an end: the employess couldn't contact the police if they suspected a mail was containing drugs (integrityreasons according to EU-legislation)

2016 Implementing the method from new circumstances. Project was finished in the end of 2016



## Goal **ordinary work**: security staff + opinion formation for changing the postal law

2016 – 2019 Policeresources decreases for working with the method, a few municipalities is working with all components of method.

Letter to departments, meeting with officials of departments, minister of justice, annual conference/meetingplace,

2020 The government decide to investigate a new law that give the employees possibility to contact police if they suspect a mail contain drugs (Ulrika from us participate in national committé)

2021 Survey with old participants in the project showed needs, and interest in working with a similar method

2022 New law underway that give the personell possibility to contact the police when they suspect drugs in mail or parcels.

We are preparing for a modified method that could help the implementation of the new law



#### How did we work with EDPQS

- We all had some fundamental education in EDPQS
- Meeting with EDPQS-consultant a few times during the projecttime
- Excelsheets that we filled in before meeting
- Reflection through EDPQS (when meetings went in circles)



#### Factors to success


 Involve the key players and main target group in the process of developing the method and change of law – importent to motivate them and feel commitment to work
